The Artists' Play event team is your go-to for all event services including audio-visual, catering, security and other.

BAR

Artists Play event space is not licensed to serve alcohol. A special occasion permit (SOP) is required for all events who wish to service alcoholic beverages. Your caterer will provide bar stand and glassware.

COAT CHECK

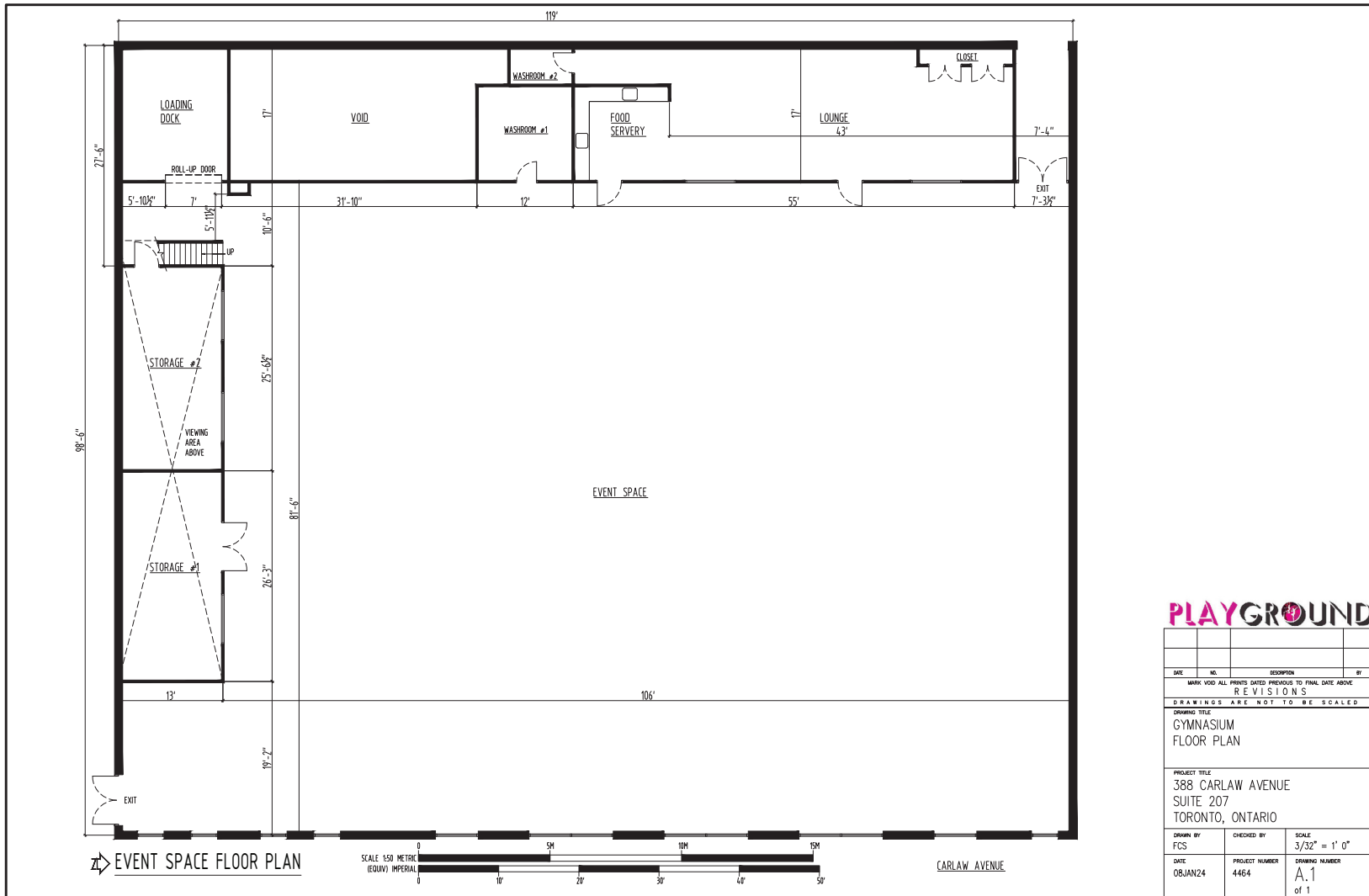
A hosted coat check can be provided for \$25.00/hour (4 hour minimum) per attendant. One (1) attendant is recommended per 100 guests.

LOAD IN & TEAR DOWN

EVENT INSURANCE + AGREEMENT

The rental term provides the renter access to the space for 24H. Any load-in and load out that expands the use of the space past this allotted amount of time may require an additional day rental and is at the discretion of AP Events to decide.

Proof of third-party liability insurance for \$2M is required with Artists' Play Inc. named on the policy for the duration of the event. The certificate must include Commercial General Liability insurance issued by an Insurance company to cover the Event. Commercial General Liability insurance shall provide a minimum liability of \$2,000,000 for bodily injury, personal injury and/or property damage in any one occurrence, shall include Host Liquor Liability if liquor is being served and shall include a cross-liability clause, naming Artists' Play Inc. as an additional insured.

Client shall provide that the Policy will not be terminated once issued, unless AP is given thirty (30) days written notice of such cancellation by registered mail. The client is responsible for ensuring that any vendor bringing equipment into the space also carries Commercial General Liability insurance with a minimum liability of \$2,000,000 for bodily injury, personal injury and/or property damage in any one occurrence and ensure their certificate names Artists' Play Inc. as an additional party insured.

Access will not be provided to the venue for the Event unless the requisite insurance documentation is secured and in place.
